Please revise to disclose how many active customers you had in previous years for comparison. In this regard, we note your response that "[b]ecause the number of active customers in 2020 was negatively impacted by the COVID-19 pandemic, our 25 million active customers in 2020 represent a decline from 32 million active customers in each of 2019 and 2018."
