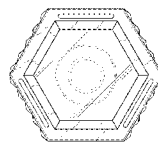
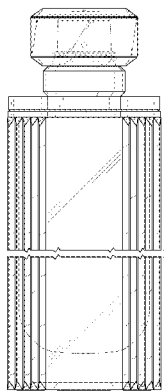
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a bottle according to our new and ornamental design;
FIG. 2 is a front elevation view thereof, wherein the rear elevation view thereof is identical except for the orientation of the spray nozzle;
FIG. 3 is a left side elevation view thereof, wherein the right side elevation view thereof is a mirror image;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a bottom perspective view thereof.
The broken lines depict portions of the bottle that form no part of the claimed design. The middle region of the bottle is shown broken away to indicate that the precise height of the bottle is not claimed. The appearance of any portion of the bottle between the two break lines forms no part of the claim.

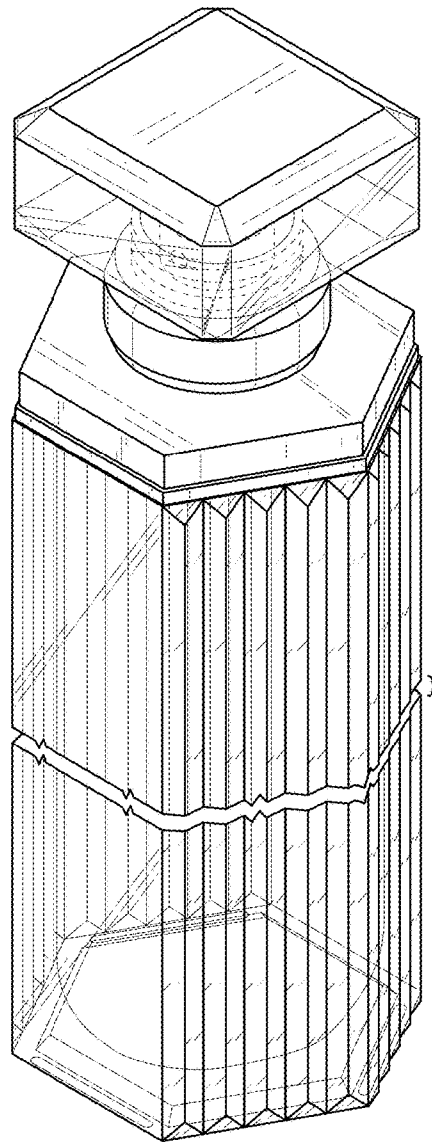

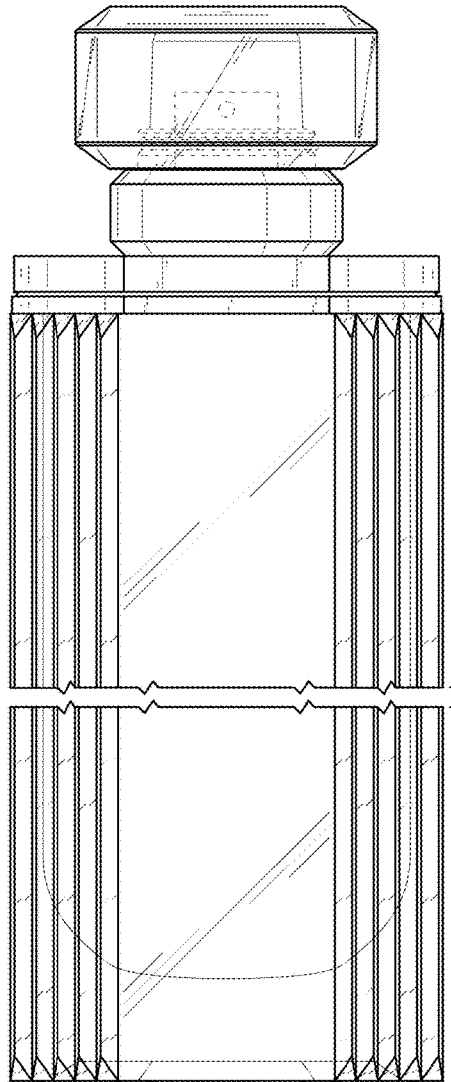

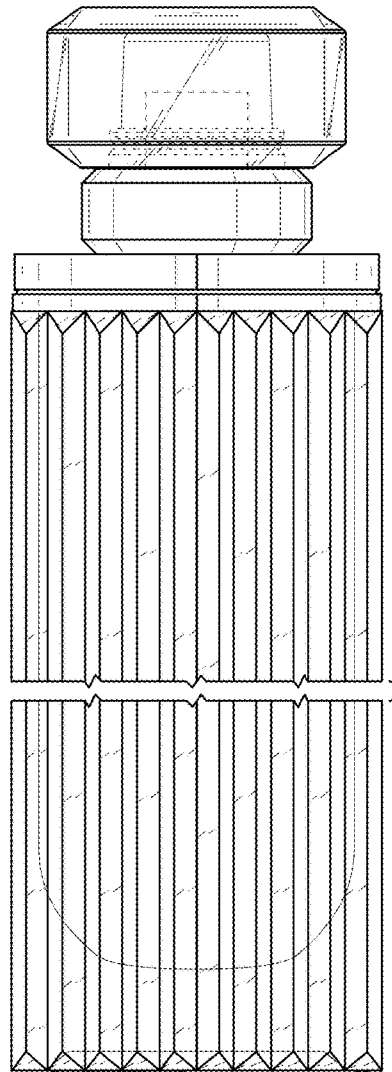

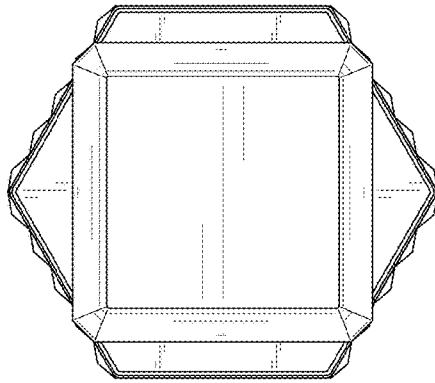

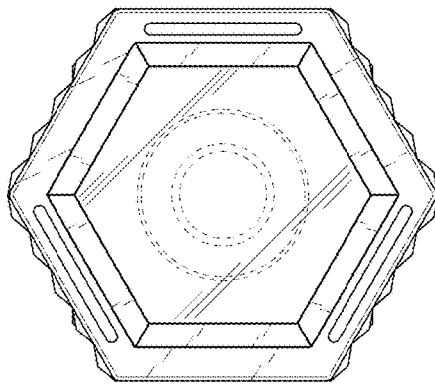

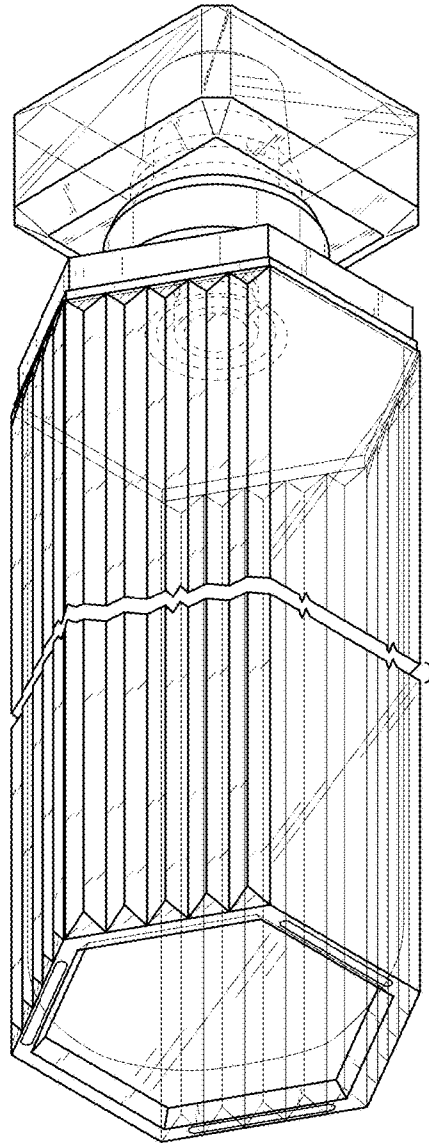
